In Madison, we like to tell people that once you visit, you'll keep coming back. With our competition nestled right in Capitol Square and just minutes from the university's picturesque campus, we think the same will be true for National Mock Trial 2014 participants

and their families. Information about the 2014 competition can be found at nationalmocktrial2014.wisbar.org.

The competition itself will take place at the Dane County Courthouse, with the final round taking place in the Wisconsin Supreme Court Chambers in the State Capitol. Event organizers are

making sure high school students have time for some fun too. The Awards Banquet and Dance will feature a DJ at the Monona Terrace. The Monona Terrace is an exciting destination in and of itself. The convention center was designed by Wisconsin native and internationally-renowned architect Frank Lloyd Wright.



Architecture is not the only thing you will be able to explore between competitions. You can check out the Dane County Farmer's Market, which is the largest producer-only farmers' market in the U.S. That means every item available for purchase was produced locally by the vendor.

The Dane County Farmer's Market takes place on Capitol Square, surrounding our state's historic center of government. The magnificent granite structure, which was built between 1906 and 1917, is open to the public weekdays from 8:00 a.m. to 6:00 p.m. and weekends rom 8:00 a.m. to 4:00 p.m. It's a true must-see. The building boasts 43 varieties of stone from around the world, glass mosaics, and hand-carved antique furniture. It's also the only granite dome in the United States, and the only State Capitol ever built on an isthmus.

Madison is also home to the world-renowned University of Wisconsin-Madison. Mock trial participants who are thinking about applying to this incredible school should take advantage and schedule a tour by going to visitbucky.wisc.edu.

If you feel like exploring beyond Madison, the Wisconsin Dells is less than an hour away. The area, which draws 3 million visitors a year, is breathtaking and fun. With natural stone formations that you can tour by duck boat, water parks, museums, and every other form of amusement you can fathom, it is definitely worth the trek. If it sounds like a lot, don't feel overwhelmed. We're recruiting a number of volunteers who will help participants, coaches and parents navigate while they are here.

HOTEL INFORMATION

TOURNAMENT/EVENT INFORMATION

The Concourse Hotel is the site of the registration desk and information, practice rooms, the meeting rooms for Thursday meetings, and team photos. The Pin Exchange and Friday evening event will also be hosted at the Concourse Hotel. The Awards Gala and Banquet will be held at the Monona Terrace Community and Convention Center. The Awards Banquet will feature a full dinner followed by a



dance hosted by a local DJ. All four rounds of the Championship will be held in the Dane County Courthouse and the Wisconsin State Capitol. The final round will be held in the Wisconsin Supreme Court Oral Hearing Room in the Wisconsin State Capitol. All of the facilities are no more than a four-block walk apart.

All teams and attendees are responsible for making their own transportation arrangements to attend the National High School Mock Trial Championship. Madison is easily accessible by air, bus or car. The Milwaukee, Chicago and Rockford, IL airports are all within a 2-hour drive of Madison. Judging Panel Sign-up and Other Volunteers Sign-up

Attorneys and Judges interested in volunteering to judge the 2014 National High School Mock Trial Championship are encouraged to complete a volunteer form as soon as possible. Each round of the tournament will be judged by a panel comprised of one presiding judge and three scoring judges. All judging materials will be provided electronically to judging panel members several weeks prior to the Championship. An orientation will be provided on the days of the Championship for judges prior to the beginning of each round. Judges and attorneys may volunteer to judge one or more rounds at their convenience. Two rounds will be held on Friday, May 9 (one morning and one afternoon); and two

rounds on Saturday, May 10 (one morning and one afternoon). Please complete the form on this link www.wisbar.org/nationalmocktrial2014 to volunteer your time as a judge. Judges for the National High School Mock Trial Championship are required to have previously judged a minimum of two rounds of a mock trial competition. If you would like to volunteer as a judge for Nationals, please contact your local Mock Trial State Coordinator to volunteer at one of the state tournaments.

Volunteers are also needed to assist with all aspects of the National High School Mock Trial Championship. Volunteers will be needed to monitor courtrooms; staff the registration and information desk; staff information desks at each of the facilities; assist with meals for judging volunteers; collect score sheets; provide directions for team members and observers to locations; and oversee each of the events (Thursday evening Pin Exchange; Friday evening event; assist with the Judges' Reception; decorations for the Awards Gala; and chaperone the dance). A Word From Our Chair

Just about a year ago in this column, I wrote these words:

"All of us in the mock trial community are very fortunate that--unlike many in our society--we regularly see and interact with the best and brightest of our high school students! We get to see the good things that they do, and we can forget, at least temporarily, all of the bad things that we hear about our country's youth. During this holiday season, remember to give thanks for these students who are a true blessing in our lives."

I want to take a moment to share some good news about one of the "best and brightest" of our former mock trial competitors--Vinay Nayak. I had the good fortune to serve on the scoring panel for the 2010 National Championship round in which Mr. Nayak's team from Hinsdale Central High School in Illinois faced the team from Breck High School in Minnesota. Although Mr. Nayak's team finished as the 2010 National Runner-Up, Mr. Nayak was awarded the Carl Oxholm III Outstanding Performance Award.

I recently learned from an internet search that Mr. Nayak--like many of the students who participate in the National High School Mock Trial Championshipwent on to a successful college mock trial career at Yale. And what a success it has been! Although Mr. Nayak's senior season still is under way, by my unofficial count, Mr. Nayak has been recognized as an outstanding attorney at four AMTA (American Mock Trial Association) invitational tournaments, three AMTA regional tournaments, two AMTA Opening Round Championship Series tournaments, and one AMTA National Championship Tournament.

While Mr. Nayak certainly is deserving of congratulations for an outstanding high school and collegiate mock trial career, his accomplishments outside of mock trial are even more commendable. On November 23, 2013, the Rhodes Trust announced that Mr. Nayak is one of only 32 Americans to be named a Rhodes Scholar for 2014. The following is from the biography released by the Rhodes Trust:

Vinay Nayak, Oak Brook, is a senior at Yale where he majors in political science. His academic work has focused on how the internet can be used to enhance citizen engagement in elections, government and policymaking. He has also applied these interests to political campaigns, including the Obama 2012 re-election campaign where he managed many national digital programs and social media

accounts. Vinay also interned for the White House Office on Digital Strategy and managed the social media presence for Sandy Hook Elementary School parents whose children lost their lives. He has won many Yale prizes, and in forensics and debate was chosen as National Oratory Champion. Vinay plans to do the master of public policy at Oxford.

Congratulations, Vinay, on your prestigious honor! All of us in the mock trial community look forward to hearing about your future accomplishments.

The Board likes to recognize former National High School Mock Trial Championship competitors like Vinay Nayak for their extraordinary achievements. Nationals 2015 Host North Carolina!

"Everyone is coming to Raleigh:" May 2015 M. Gordon Widenhouse, Jr. (North Carolina) Host Board Director

After a trial laced with hearsay, Sir Walter Raleigh, who conducted his own defense (perhaps an unwise decision), was convicted of treason and eventually beheaded. The national high school mock trial championship will come to the city named for him May 14-16, 2015.



The Carolina Center for Civic Education, which operates North Carolina's high school mock trial program, will host the event. We pledge to provide an exciting competition with no fear of decapitations.

The new Wake County Courthouse opened on schedule in 2013 and will be the site of the competition. The Final Round will likely be held in the United States Courthouse, only a few blocks from the county courthouse. Rooms are available at the Marriott Raleigh City Center (\$145.00 per night) and Sheraton Raleigh Hotel (\$129.00 per night), both of which are within two blocks of the competition site.

The Campbell University school of Law, which hosts the finals of our state competition, is also only a short walk from the hotels and courthouse and will be a venue for some activities. The Judges Reception will likely be held in the rotunda of the law school. The always-anticipated Pin Exchange, which will also include an Opening Ceremony for the tournament, will be at the Sheraton. The Awards Ceremony will be on Saturday evening at the Raleigh Convention Center, which is adjacent to the hotels.

Downtown Raleigh is vibrant and offers a wide range of entertainment venues, restaurants, and other establishments. Artsplosure, an annual downtown celebration and festival of artists and artisans, will coincide with nationals and provide scores of venues for amusement.

CCCE enjoys strong support from many local judges, including Justices on the Supreme Court of North Carolina and Judges on the North Carolina Court of Appeals. The historic building that houses the Supreme Court is only a few blocks from the competition headquarters, as are the newly renovated home of the Court of Appeals and the Capitol. Work is underway on what we hope will be an exciting and challenging case. While other activities are in the planning stages, it bears remembering that North Carolina is the birthplace of Pepsi, the home of barbecue, and the source of that culinary delight: collards. These treats, along with others, are sure to make an appearance during the social events.

The CCCE and the local bench and bar eagerly anticipate the May 2015 event. Renowned southern hospitality awaits you.

Announcing **The Larry Bakko Professionalism and Civility Award**. The *Larry Bakko Professionalism and Civility Award* is sponsored by the National High School Mock Trial Championship and was created to highlight the importance of professionalism among teams participating in our national tournament while honoring Larry Bakko's passion and dedication for Mock Trial.

The Team Professionalism Award nomination ballot will be included in your team's registration packet. During the competition experience, your team and coaches will observe other participating teams and, using a subjective process, will nominate another team to be considered for the Larry Bakko Professionalism and Civility Award. Teams may take into account the behavior of students, coaches and spectators associated with other teams when making a nomination for this award.

Teams may not campaign for this award. When discussing this award with students, it is hoped that coaches will emphasize the importance of professional behavior inside and outside the courtroom throughout the competition. The discussion of this award will provide you with an excellent opportunity to review the Code of Ethical Conduct and the Rules of the Competition that deal with ethics and decorum. Discussions about this award will provide coaches the opportunity to discuss the high standards of professionalism attorneys are held to as members of the Bar.

The qualities that teams nominated for the award must demonstrate include:

- A professional demeanor
- Civility
- Integrity
- Honesty
- Fair play
- Respect for the court
- Respect for opposing counsel
- Respect for the client

Each team must submit one team ballot nominating another team for the Professionalism Award. A team may not nominate itself. A team may nominate another team that they competed against in one of their rounds, or not, as it sees fit. The NHSMTC Board of Directors will not recommend a particular process by which each team determines their nomination, but suggests that coaches take student input into account when completing the nomination ballot. How a team reaches the decision to nominate another team for this award is completely within the purview of that team.

All ballots are due before a team leaves the courthouse and after the fourth round on Saturday. Ballots will be submitted to the courtroom liaison and turned in with the scoresheets. Do not exit the building before submitting the Larry Bakko Professionalism and Civility Award nomination ballot. For questions regarding this award, contact Cynthia H. Rules Committee

The National Board adopted two changes to the rules governing the national championship tournament at its meeting on October 12. First, Rule of Evidence 803(6)(D), deleting the reference to Rules of Evidence 902(11) and 902(12), which do not exist in mock trial. Two changes were made to Rule 4.11, relating to supplemental materials. The first makes clear that roster forms cannot be modified by teams, for example to add pictures of the team members. Only that information called for on the roster forms provided with the competition materials may be included. The second change clarifies an ambiguity regarding whether materials in the case can be marked by the teams during the trial. The amended Rule 4.11 makes clear the limited circumstances under which such markings can be made and the limited use to which such marked documents may be put during trial.

New Rule of Evidence 803 (6)(D) now reads:

- (6) Records of a Regularly Conducted Activity. A record of an act, event, condition, opinion, or diagnosis if:
 - (A) the record was made at or near the time by or from information transmitted by someone with knowledge;
 - (B) the record was kept in the course of a regularly conducted activity of a business, organization, occupation, or calling, whether or not for profit;
 - (C) making the record was a regular practice of that activity;
 - (D) all these conditions are shown by the testimony of the custodian or another qualified witness; and
 - (E) neither the source of information nor the method or circumstances of preparation indicate a lack of trustworthiness.

New Rule of Competition 4.11 now reads:

Supplemental Material; Costuming

Teams may refer only to materials included in the trial packet. No illustrative aids of any kind may be used, unless provided in the case packet. No enlargements of the case materials will be permitted. Absolutely no props or costumes are permitted unless authorized specifically in the case materials. Costuming is defined as hairstyles, clothing, accessories, and make-up which are case-specific.

The only documents which the teams may present to the presiding judge or scoring panel are the individual exhibits as they are introduced into evidence and the team roster forms. No roster forms may be altered except to provide the information requested. No exhibits may be modified before trial, but attorneys and witnesses may mark exhibits during direct or cross examination. Such marked documents may be used as demonstrative exhibits during the trial and during closing arguments, but may not be entered into evidence. If a team wishes to mark an exhibit entered by the opposing team, it must substitute its own clean copy of that exhibit for this purpose before any markings are made. Exhibit notebooks are not to be provided to the presiding judge or scoring panel. Unless provided by the host committee, name tags or name plates at counsel table are not permitted.



WE THE PEOPLE

"We the people of the United States, in order to form a more perfect union, establish justice, insure domestic tranquility, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America."

These 52 words begin the document that has guided governance of the United States since September 17, 1787, and defined what it means to be an American. With just 27 amendments, the Constitution has held our country together for 226 years.

The Constitution was written by 55 men who came together in Philadelphia to create a Constitution that would replace the failing Articles of Confederation. The writers had a great sense of purpose – to save our country from failure.

The first 10 amendments to the Constitution — the Bill of Rights — were added by 1791, as an "Operator's Manual" and explained how the Constitution should be used. They assured our rights were clearly stated, including better definitions of due process (basic fairness), and they gave the people a clear voice in governing. We have a right to free expression, as a result, and we have the right to confront an accuser and to try our case before a jury.

In 1865 when the 13th and 14th Amendments were passed, with the rights granted by the Constitution and the first 10 Amendments, the states also had to treat us fairly with due process, and slavery was abolished.

Many of the rights derived from our Constitutional battles are still threatened every day, perhaps none more so than the 6th and 7th Amendments, which give us the right to a trial by a jury in all civil and criminal cases. We are in danger of losing the critical checks and balances that our founders believed were at the center of our justice system, embodied in a jury trial, where we speak our minds and express our values.

The American Board of Trial Advocates and its educational foundation are committed to teaching young Americans, lawyers, judges, legislators and our Executive Branch of government about the right to trial by jury – a critical freedom that defines the American experience and makes us the envy of the world.

Arkansas

It's Mock Trial season, and there are a lot of changes in Arkansas this year! Traditionally, the Arkansas competition held single-elimination tournaments on a Regional and State level. In an effort to provide more trial time and a better experience for our students, we will be hosting a two-day round robin tournament in Little Rock on Friday, February 21, 2014 and Saturday, February 22, 2014. There will be three preliminary rounds of competition, and the championship round will be held Saturday evening. This is a big change for our state, and we will need to recruit twice as many volunteers to serve as presiding and scoring judges for the competition. We have been successful in our recruitment efforts so far, so we're optimistic about getting the number of volunteers we need this year.

Our registration opened in September, and case materials were released October 22. Our case is an aggravated assault case, adapted from a case originally published by Georgia. The students are already excited, and I can't wait to see it in the courtroom.

The Mock Trial Committee was contacted by an attorney coach that would like to start a suit project for Mock Trial students. She plans on organizing a donation program, making suits available to students that may not be able to purchase one. She heard about similar programs in other states (kudos to those of you that are already doing this!) and was motivated to get her team involved in collecting and distributing the suits. She is working out the logistics, but the Arkansas Mock Trial Committee will be in support of her efforts and will be spreading the word. The suits will be given to students in need. Not only can the students use the suits for the Mock Trial Competition, but also for college and business interviews! Colorado

The Colorado Bar Association High School Mock Trial Committee released its original case problem on November 1, 2013. This year, the committee collaborated with a national awareness initiative on Distracted Driving called ENDDD. Check out their website at http://enddd.org/ The case problem was inspired by this initiative in hopes to teach students the consequences of distracted driving. On June 26, 2013, Cody Ortiz, a student at Golden High School drove into an intersection in Golden, Colorado, while, at the same time Elliot Cook, a working parent at the Colorado School of Mines, started to cross through the intersection on a bicycle. The two collided and Elliot Cook was hurt. Right before driving into the intersection, Cody Ortiz looked down at a text message that had just come through on Cody's smart phone. While riding into the intersection, Elliot Cook was talking on Elliot's smart phone. Both parties claim the other one had a red light. Two witnesses, Finley Bush and Sawyer Beard, saw the accident, but both have their own biases. Finley Bush doesn't like Cody Ortiz, and Sawyer Beard doesn't like bicyclists. Skylar Turner, an expert on distracted driving, blames the accident on Cody Ortiz. Parker Madden, an accident reconstructionist, says it was Elliot Cook's fault. Who's at fault?

Additionally, we wanted to do more with the ENDDD initiative. Attorney volunteers will be trained and assigned to schools to speak about the END initiative. We have a goal of 10,000 students to reach and have sign the pledge to end distracted driving.

Georgia

The Georgia High School Mock Trial Competition registered 133 teams for the 2014 season which will compete in 16 Regions across the State. The season started with the 16th annual Law Academy, held at the State Bar of Georgia's conference facilities over the weekend of September 19-22. We hosted 29 students from around the State for large and small group sessions led by attorneys and judges involved with the program on all manner of topics to help the students improve all areas of their mock trial skills.

This year's case of *Georgia v. Pyke* was released in early October and centers around the murder of a loan shark who was thrown to his death off the city's parking garage structure. The defendant is a local drug dealer, who says he left the meeting with the victim alive and saw someone else push him over from across the deck. Two witnesses see the push but disagree on the pusher. The students will have various crime scene photos to work with this season. We will also be hosting the annual Court Artist contest again this season, hopefully bringing the State Champion Artist to Madison.

The program made a big adjustment to the season's schedule with the addition of the District level of competitions. After the Regional competitions take place January 25 & February 1, the top three teams from each Region will advance to the District Competitions on February 22 to decide the District Champion and move on to the State Finals Tournament. While the State Finals Tournament will now have 8 teams (down from the 18 in season's past), the addition of the District Competition gives 48 teams a chance at competition beyond Regionals compared to the 18 last season. In addition, teams will have to go through more competitions to reach the State Finals weekend on March 15. We are excited about our expanded competition schedule and having many more teams compete deep into February.

Illinois

Nevada

teams in Southern Nevada and 8 teams in Northern Nevada. The Regional competitions will be February 8th 2014 in Las Vegas; February 21st in Reno; and the State Competition will be March 7th and March 8th in Las Vegas. We had a Mock Trial Workshop on October 19, 2013 at Canyon Springs High School's courtroom for new Mock Trial teachers, coaches and students. We were happy with the turnout of 22 students, 8 teachers, and then 8 presenters and coordinators who covered Direct Exam;



Cross Exam; Objections; Openings and Closings. We provided pizza for everyone.

Michigan

Center for Civic Education

Registration is underway for the 31st annual Michigan High School Mock Trial Tournament. We continue to move ahead with our plan for expansion and increased participation for MHSMTT and have added a new Regional Tournament at the Macomb County Circuit Court. We are now pleased to offer four regional tournaments across Michigan (twice the number of two years ago). The top ten teams from the Regional Tournaments will compete at the State Finals on March 29 at Veteran's Courthouse in Lansing, our state capitol.

This expansion is made possible through funding support from the State Bar of Michigan, the Oakland County Bar Foundation, the Litigation Section, State Bar of Michigan, and the Macomb County Bar Foundation.

This year's case is People v. Sam Seaside, a criminal case of a high-school student accused of the murder of a fellow classmate who went missing after a late-night party. We thank the Colorado Bar Association for letting us adapt and use their case.

Our annual Mock Trial Clinic for students will be held November 21 at Cooley Law School's Auburn Hills campus, Students may also attend via distance-education video conference at the Cooley Law School campuses in Grand Rapids or Ann Arbor.

North Carolina

Many exciting developments are taking place in North Carolina as we work to expand our program and prepare for hosting Nationals in 2015. We held our first-ever 3 day summer mock trial camps at two locations (Fayetteville and Chapel Hill), which enrolled nearly three times as many students as we had anticipated! Judges and attorneys volunteered their time to lead sessions on all aspects of mock trial, and students put their knowledge into practice by presenting one side of a camp competition case as a culminating activity. Parents and family members were very impressed by all that their students had accomplished in such a short time period.

The camps generated great enthusiasm leading into the start of the season, and we have already registered 81 teams, with an anticipated final enrollment approaching 90 teams (an increase of 25% over 2012-13 if current trends hold). Seventeen of the teams are brand-new to the program this year, and another fourteen teams are only in their second year of participation. Grant funding has allowed us to develop additional training materials and offer free on-site team training sessions for new schools, which has been pivotal in our Outreach Project success.

Written as an original case for this year's competition, *State of Utopia v. Quinn Penner* is a criminal case in which a police officer is charged with the murder of a local drug dealer. The case introduces students to a number of interesting topics, including parkour ("free-running") and forensic analysis. We again were able to draw upon local connections and expertise, as Maher "Max" Noureddine, PhD and President of ForensiGen, LLC, assisted with the description of DNA analysis.

Students will compete at eight Regional competition sites statewide on Feb. 1, 2014, with the regional winners advancing to state finals on Feb. 28 – March 1. The CCCE is very grateful to all of our regional and state finals sponsors, Campbell Law School (our state finals host), the North Carolina Advocates for Justice, and our Outreach Project sponsors for their ongoing support of our mock trial program.

New Jersey

Late on a rainy evening in April, a car with two young occupants, Sid Sawyer and Cathy Sawyer, crashed into a tree on a desolate road. Cathy, Sid's sister, was

Students then organize to protest this action both in school and on the field itself. The school district responds by installing security cameras and searching the lockers of the students involved as well as filing an action to remove the students from the field. The students claim the school district has violated their First and Fourth Amendment rights.


